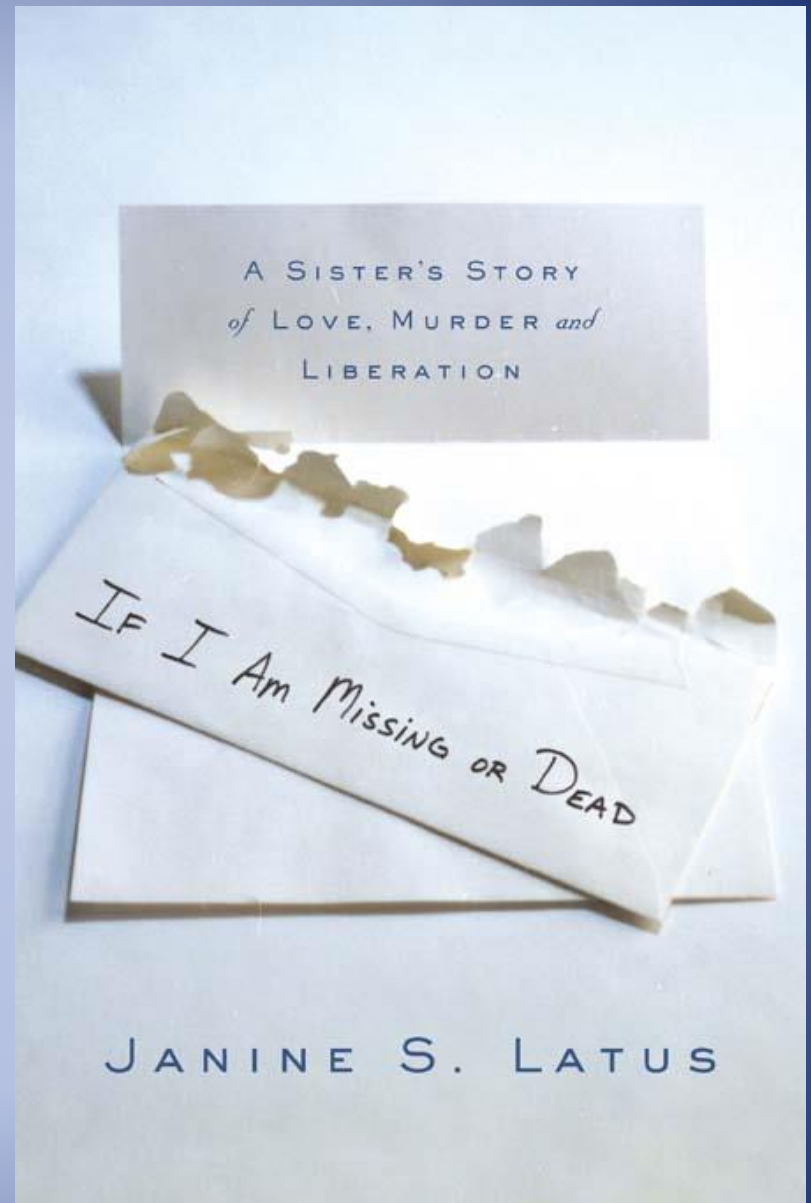


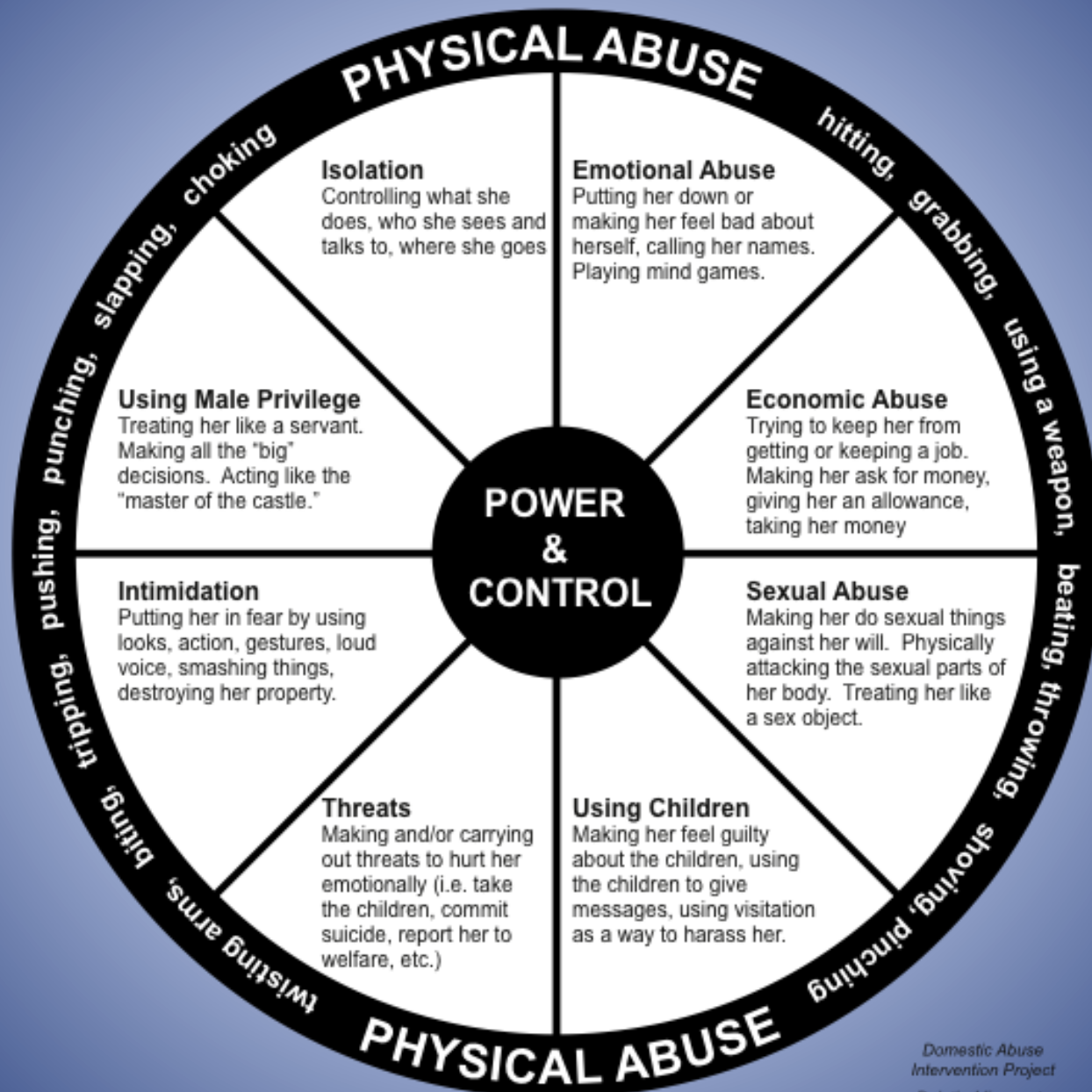

Sexual Abuse

Includes forcing or coercing partner to perform sexual acts against that person's will.

Financial Abuse

Includes withholding money, interfering with partner's ability to earn an income, hiding money and expenditures.

Cyber Manipulation

Includes monitoring GPS tracker on phone or car, manipulating smart home appliances to gaslight victim, insisting on going through phone or social media, impersonating victim via messaging apps or social media to alienate allies.

Emotional/Verbal Abuse

Includes belittling, criticizing, name calling, humiliating, stalking, monitoring, excessive jealousy, threats to partner or self, children or pets.

Physical Abuse

Includes shoving, pinching, slapping, pinning, punching, twisting, choking, stabbing, shooting

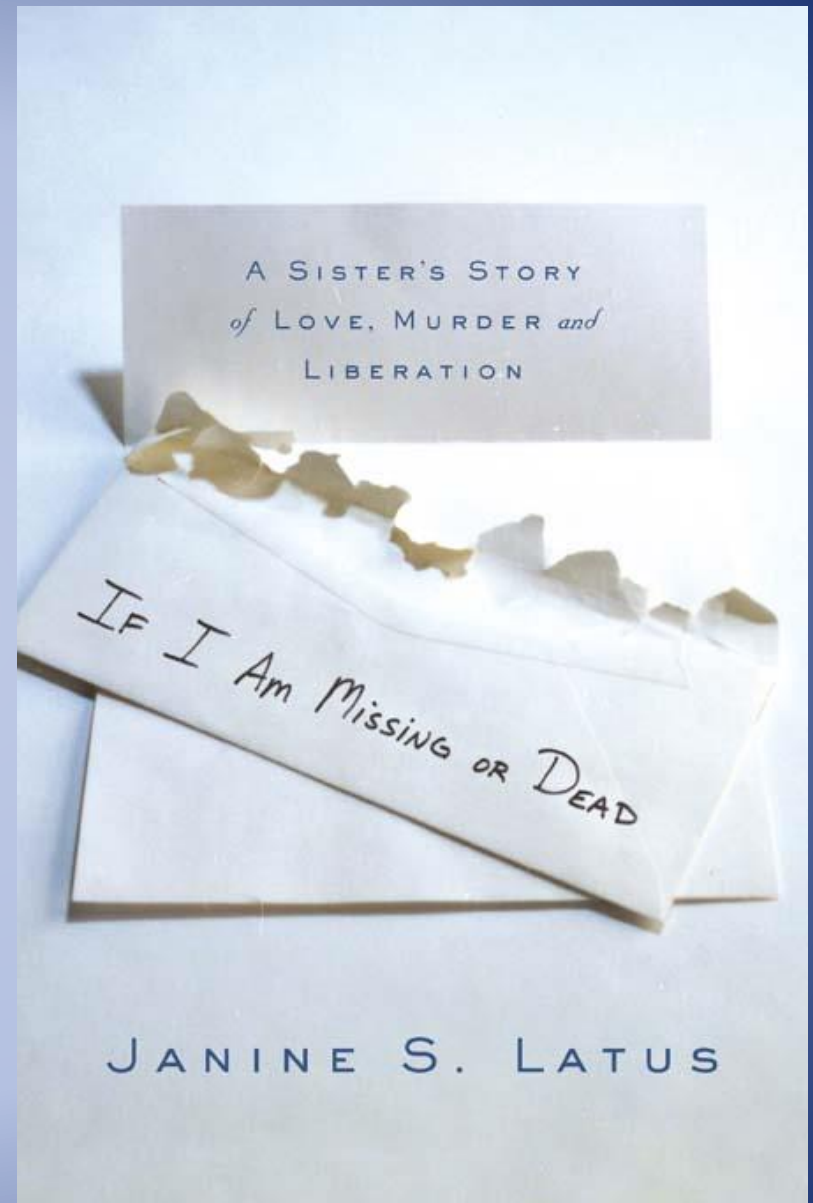
